How We Collect Your Information

Additionally, we will source information about you that is publicly available online through employment websites, publications, clinical trials, and otherwise.

What Information We Collect

When you agree to join our expert panel, we may collect the following personal data:

- Full name
- Email address
- Preferred contact number
- Year of qualification as a healthcare professional
- Professional title and specialty
- Place and location of employment
- Date of joining our expert network
- Date of email confirmation and consent
- Tax Identification Number or Employee Identification Number (for tax purposes)
- Home address or banking information (for honoraria processing)

We do not collect any Special Categories of personal data, such as racial or ethnic origin, political opinions, religious beliefs, trade union membership, or health/genetic/biometric data.

How We Use Your Information

ClearView Healthcare Partners will process your data to invite you to participate in market research projects. The personal data we collect will only be used lawfully and appropriately. Personal data is supplied willingly by experts to ClearView Healthcare Partners and are to be processed only for correspondence and project purposes outlined below. We also utilize the information collected to process your invoices and administer honoraria after the completion of the interview or survey.

We process your personal data solely for legitimate business purposes, including:
